2. Referral codes cannot be used in conjunction with any other offer, other than Pentanet's RAC member discount, if the applicant meets the eligibility criteria for that individual promotion.
3. Gift cards cannot be transferred to another person or redeemed for cash or credit.
4. Gift cards will be issued within 20 business days after the successful service activation has taken place.
